## SMALL BUSINESS COUNCIL OF AMERICA HONORS MEMBERS OF CONGRESS AND SMALL BUSINESS OWNERS DURING 36<sup>th</sup> Annual Public Affairs Day and Congressional Awards Reception

**WASHINGTON, D.C.** (May 10, 2019) – On May 8, 2019, the Small Business Council of America (SBCA) held its 36<sup>th</sup> Annual Public Affairs Day and Congressional Awards Reception in Washington, D.C. The SBCA is a national non-partisan nonprofit organization which for forty years has represented the interests of more than 100,000 privately-held and family-owned organizations on federal tax, employee benefit and health care issues.

The Public Affairs Day and Congressional Awards Reception, which has long been the highlight of the SBCA's annual calendar, featured discussions about the critical issues facing small businesses and the presentation of awards to members of Congress and small business owners.

Congresswoman Nydia Velázquez (D-NY) received the SBCA's Special Congressional Appreciation Award in recognition of her active and dedicated leadership on behalf of the country's small businesses as Chair of the House Small Business Committee. The Special Congressional Appreciation Award is the SBCA's highest Congressional Award and has been presented just a handful of times during the SBCA's distinguished history. Congresswoman Velázquez previously received the SBCA's Congressional Award in 2002.

Congressman Ed Case (D-HI) received the SBCA's Special Congressional Award Appreciation Award in recognition of his keen understanding of small business issues and his dedication to promoting fiscally responsible solutions in Congress.
